MINUTES OF "DISTRICT DEVELOPMENT COMMITTEE MEETING" OF JORHAT DISTRICT FOR THE MONTH OF MARCH, 2023

The meeting was presided over by Shri. Pulak Mahanta, ACS, Deputy Commissioner Jorhat. The chairperson extended his greetings and welcomed all. ADC (Dev) Shri Arun Kr. Brahma, ACS, was instructed to take a brief review of the issues discussed in last DDC meeting held in the month of February, 2023.

Brief highlights of the review taken on action points from Feb' DDC Meeting:

Health	 The Chairperson inquired about the health indicators (IMR, MMR). MMR has been a sensitive issue for Jorhat and ASHA workers involved have been identified as weak link towards betterment in MMR. 	Chairperson stressed on quickly organizing training programmes for ASHA workers. DC, Jorhat will personally so into the matter.

Discussions on CM Dashboard: Monitorable Indicators and CM's Conference

The Chairperson brought into light the lagging status of Jorhat district in some of the monitorable indicators due to which the overall ranking of Jorhat District remains low. The Chairperson, hence, warranted swift and sincere action from all respective Heads of departments and emphasized on consequent reporting. In this regard, the Chairperson went about discussing the following 12 major Monitorable Indicators.

The Chairperson suggested lifting in advance and making space in FCI godowns. The Chairperson urged SDO(C) Titabor to ensure paddy procurement and FCI godown space management. ADOs were directed by The Chairperson to ensure paddy procurement at price not less than MSP. The Chairperson also suggested SDO(C) to ensure that payments are administered through EPOS mechanism to avoid leakage. 	Supdt. FCS & CA instructed to complete entire process immediately .

The Chairperson also inquired about AADHAAR enrolment status. In this regard, The Chairperson directed ADC (Dev), Assistant Commissioner Parineeta Chakraborty, ACS and ALC to work in cohesion and achieve desired targets. He suggested to enrol more Data Entry Operators if required. The Chairperson further suggested all Heads of Departments to report their developmental activities on social media platforms tagging relevant State Government Ministries and Hon'ble CM of Assam. Also regarding PMAY-G standing issue in Titabor sub-division, The Chairperson instructed SDO(C) Titabor to check for feasible plot for constructing houses in a clustered fashion whereby all public facilities could be available and make it a model village.
