

MINUTES OF DISTRICT DEVELOPMENT COMMITTEE MEETING OF JORHAT DISTRICT FOR THE MONTH OF JUNE '2022 HELD ON 27/06/2022, IN THE CONFERENCE HALL OF DEPUTY COMMISSIONER'S OFFICE, JORHAT

The members present are at Annexure I.

The meeting was presided over by Sri Ashok Kr. Barman, IAS, Deputy Commissioner, Jorhat. The Deputy Commissioner, Jorhat welcomed all the members present and initiated the discussion.

The progress of works of various development departments were elaborately discussed in the meeting and decisions were arrived as follows:

PHE

During review of last meeting minutes in a query from Chair, the EE, PHE, Jorhat intimated that the Contractor who is constructing the Roads within the Honowal TE will compensate the labour cost amounting Rs. 82,000/- for restoration of distribution pipeline from Greater Mariani PWS and also informed that EE PWD Mariani, Teok Road Divn. has ensured to give compensation through the concerned contractors.

EE, PHE, Jorhat also informed the house that as per decision of the last DDC meeting, work orders for drinking water arrangement in Schools and AWCs has already been issued to original registered PHE Contractors and intimated that out of total 453 AWC, electricity connection yet to be done in 279 centers. He also informed that most of the teachers of concerned schools are not willing to be the custodians of Pumps during Summer Vacation period. In this connection IS/DEEO & DSWO were instructed to issue notification to all School Heads and AWC to keep pumps and electric motors in their safe custody and all School Heads will take over the schemes immediately after successful completion.

EE PWD Jorhat, Titabor Road Division informed that they will allow to lay pipe lines along Chinnamora –Moriani and Chinnamora – Titabor Road from Greater Jorhat PWSS. The Chairperson instructed EE PHE, to communicate with PWD Roads regarding commitment to deposit the compensation as and when received from the Govt.

Participating in the discussion, ADC (Dev) viewed that due to lack of coordination among the departments various problems arise during execution of works specially construction of Roads, so it was requested PHE, APDCL & PWD department to keep proper coordination before starting the works.

In reply to a query from Chair, the representative of NHIDCL, informed that they will complete the utility shifting works in 2 (two) pipe water supply schemes along Jorhat –Dergaon Road within 10 days and they will start the shifting works in 13 nos PWSS in Jorhat –Jhanji section within a short period.

Regarding restoration works in the breach portion of Gohain Gaon area, EE WR (UAD) assured to complete the entire works within 15 days.

Irrigation

The Chairperson instructed to conduct a joint survey with APDCL for entire 425 installed points under PMKSY and sort out the power issues so that all pumps may become functional. For multiple cropping, it was directed to prepare a comprehensive plan.

Agriculture

The representative of DAO informed that there is a gap between Aadhar seeding of PM Kisan beneficiary and process is going on to minimize the gap soon. The data rectification is also continued. The Chairperson instructed to complete immediately and also directed to submit the list to CEO, ZP Jorhat for verification. SDO (C), Titabor informed that Circle wise Farmers registration data yet to be received and requested to submit immediately. It has been observed that due to lack of coordination within the department proper figure was not reflected in the reports and strictly directed to be careful in future.

Education

Inspector of Schools, Jorhat informed that the high level committee meeting for finalization of School amalgamation will be held on 30th June'22. The Chairperson directed the IS, Jorhat to place the list of Schools for amalgamation with proper justifications with zero error.

Health

Jt. Dir, Health informed that 2 (two) new JE cases have been detected, one from Upper Sagun Para, Kakojan and another from Solmora area. As precautionary measures, DVO also informed that samples from local piggery also collected but report yet to be received. The Chairperson instructed both the Jt. Dir & DVO to stay alert and frequently visit the suspected areas of the district and take all preventive measures. The Jt. Dir., also informed that two covid cases also found in the district and health deptt. is ready to cope up with all kind of adverse situation.

Participating in the discussion SDO (C) , Titabor informed that due to severe shortage of Doctors , in Titabor Civil Hospital lots of problems arise and requested the Jt. Dir, Health, Jorhat to make an order for placement of Dr. Kurmi in Titabor who is presently posed at Jorhat , Jail.

Sericulture

Asstt. Dir. was instructed to engage all officials of Sericulture Department not only the Gd-IV employees for cleanliness of Seri Firms in rotation basis and for that motivate all the staffs and local people. The Chairperson instructed the Asstt. Dir., to prepare a plan, to expansion of Eri Cultivation in the district and to submit the same to the District Administration. She was also requested to include Eri plantation in the convergent plan.

NHIDCL

On a query from Chair, the representative of NHIDCL, Jorhat informed that due to bad weather, highway work could not be done and assured to complete the repairing works within 15 days. DTO also requested the NHIDCL authority, Jorhat to develop Way Side Amenities for Truckers, so that nos of accident cases may be controlled.

APDCL

SDO (C), Titabor informed that, Titabor Sub Division has been facing horrible condition of Power Cut up to 12 hrs in the name of tree cutting in Titabor Borhulla road / Titabor Mariani Road, frequently, as a results works in emergency nature are hampered to a great extent. In this regards, no positive replies received from Forest Department. She requested the APDCL authority to look in to the matter properly and to minimize the load shedding. The Chairperson requested SDO (C) to communicate with DFO directly and report accordingly. He also appealed all Heads of Department to identify the vulnerable Trees within their Office campus and surroundings and specially requested the PWD (R) authority to identify such trees within the roads and intimated DFO for trimming and report.

Misc

- CEO , ZP , Jorhat informed that the condition of Moinaporia –DoloiGaon Road is too bad which is not even walkable and requested the PWD (Rd) to include in the proposed plan.
- SDO (C) also intimated that the condition of Borhula-Mariani Road and Borhula – Na Ali Road is worst at present and requested PWD to repair the said roads as early as possible . In this connection PWD authority informed that Borhula – Na Ali Road is proposed under CSR fund of ONGC and at present needs recasting the estimates. It was informed that ONGC CSR funding process is very much slow, so it may be proposed under Asom Mala.
- DVO was instructed to finalize exposure tour to Gattani's Vermicompost projects as a inspirational and motivational tour for young entrepreneur.
- PHE Department was requested to inspect the Drinking Water facility system of Observation Home, Lichubari and requested to clean it and also make a proposal for repairing of the project.
- EO , JMB informed that JMB is not ready to pay the outstanding electricity bills for Urban Water Supply which was recently taken over by JMB and requested Urban Water supply to submit a written request letter for clearance. EO, JMB was also requested to introduce online system for payment of Water Supply Bills.

The meeting ended with a vote of thanks from the Chair.
