

MINUTES OF DISTRICT DEVELOPMENT COMMITTEE MEETING OF JORHAT DISTRICT FOR THE MONTH OF DECEMBER '2021 HELD ON 21/12/2021, IN THE CONFERENCE HALL OF THE NGAL GUEST HOUSE ,TITABOR

The members present are at Annexure I.

Due to some preoccupied official urgency of Deputy Commissioner, Jorhat , Sri Adhar Bhuyan, ACS, District Development Commissioner, Jorhat presided over the meeting. The Chairperson welcomed all the members present and initiated the discussion.

The progress of works of various development department are elaborately discussed in the meeting and decision arrived as follows

1. Handloom & Textile

As reported by Asstt. Dir., H&T, Jrt , under Mudra Loan , out of the target of 200 , so far 125 application has been received and ,99 application already sent to the concerned Bank Branches and scrutiny of 26 application under process . Under APART 120 beneficiaries are benefitted in weaving, dying and design development by training programme and 215 no Yarn Pass Book issued to the weavers for the year 2021-22. The Chairperson directed the A.D, H&T to expedite complete the entire process of Mudra Loan with in this financial year.

2. IRRIGATION

The EE , Irrigation, Jorhat/Dergaon/ Teok Divn, informed that in Jorhat /Dergaon & Teok LAC the Electric Operated Tube Wells installed under PMKSY are functional, but poor discharge due to low voltage and needed rectification and communication has also been made with APDCL in this regards . .The Chairperson requested the APDCL authority to look into the matter and take necessary steps immediately.

3. SOIL CONSERVATION

The D O soil Conservation informed that proposal for an amount of Rs.414.00 Lakhs against 6 schemes under RIDF , Rs.67.00 against 2 schemes under RKVY and Rs.155.00 Lakhs against 6 Schemes under SOPD for the year 2021- 22 has been submitted to the Govt. for approval . For the year 2019 -20 & 2020-21 two schemes under SOPD –G and 1 scheme under RIDF are in progress but fund yet to be received from Govt.

4. LABOUR

The Asstt. Commissioner, Labour , Jorhat informed the meeting that the Ministry of Labour & Employment , GoI designed a portal “ e-SHRAM” to mobilize unorganized workers such as MGNREGA , SHG members under NRLM/NULM, Street Vendors , Rikshow puller, Anganwadi Workers , Mid Day Meal workers , Domestic Workers ASHA Workers , Agricultural Workers etc through respective line department and register under e-SHRAM .He intimated that Dist. Level Committee also constitute for mobilization of unorganized works and requested all concerned Dev Department to extend their cooperation for enrollment and registration of such workers under the said portal.

5. PWD (Building) ,

The E.E. PWD Jorhat Bldg. Divn, Jorhat informed the meeting that works of Women University, Assam is not progress due to land related problem and requested Dist. Administration to sort out the problem so the works can be initiated. In this connection the ADC (Dev), suggested for advance possession. The remaining works of Treasury Building could not be completed due to non receipt of pending bills of about .80.00 Lakhs The Chairman requested to communicate with Govt. and intimate accordingly. The EE PWD (Electrical) also informed that bill against the electrical works of Commissioners Office is also pending.

6. APDCL

The DGM APDCL informed the meeting that they have some issues with NHIDCL regarding shifting and construction works of underground Highway crossing for APDCLs 33/11KV lines and shifting & construction of 33 KV Pulibor Substation . The Chairperson instructed the NHIDCL authority to communicate with APDCL in this regard and to sort out the matter by joint verification. The DGM also requested the district administration to allot suitable land for setting up of new 33 KV substation under AIIB at Jorhat Court Field . In a query from Chair the DGM intimated that still there is huge outstanding bills to be paid by Urban Water Supply Department. The Chairperson instructed the EE Urban Water to clear the arrear electricity Bills as early as possible.

7. The Dy. Director T&CP informed that the ongoing Multi Storied Car parking targeted to complete with in March/22.

8. The Addl. Deputy Commissioner (Dev), Jorhat requested all the Heads of the Department for a plastic free office campus , issue necessary instructions not to use single used plastics within their Office campus and aware all officials .

9. The CEO, ZP, Jorhat instructed the EE , WR to complete all the ongoing /incomplete works of vulnerable Embankment point of Jorhat immediately before the rainy season.

10. After detail discussion on progress of works of PMAGY (SC) works , it was decided to clear all outstanding bills by rectifying the P&E if necessary and Chairperson requested the CEO ,ZP, Jorhat to look in to the matter personally for speedy completion of works, as Govt. is pressing hard for utilized 100% fund.

11. Participating in the discussion the DAO, Jorhat intimated that , Agriculture department is going to cultivate Maize as alternative crop in the 50 Bighas of Land given by Thangal Autonomous Council in Titabor and offered special thanks for offering land to the Council. The meeting appreciated the efforts of Thangal Council and anticipated such cooperation in coming days also.

The meeting ended with a vote of thanks from the Chair.
