MINUTES OF DISTRICT DEVELOPMENT COMMITTEE MEETING OF JORHAT DISTRICT FOR THE MONTH OF SEPTEMBER '2021 HELD ON 04/09/2021, IN THE CONFERENCE HALL OF DEPUTY COMMISSIONER'S OFFICE JORHAT

The members present are at Annexure I.

The meeting was presided over by Sri Ashok Kr. Barman, IAS, Deputy Commissioner, Jorhat. The Deputy Commissioner, Jorhat welcomed all the members present and initiated the discussion.

The meeting discussed and reviewed various topics and attained decision as follows:

1. Poshan Abhiyan

In the beginning of the meeting the Chairperson requested the DSWO for detailing about "Poshan Month". In reply, the representative of Social Welfare Department informed that "Eradication of Malnutrition" is the motto of "Poshan Abhiyan" and elaborately explained the various activities to be taken up in this regard. She intimated that 14 other Dev. department are also involved in the Poshan Abhiyan and outlined the roles and responsibilities of line departments to make this Poshan Mela successful.

After detail discussion following decisions were taken:

- i. DGM assured to provide electrification to the Anganwadi centers by Nov, 2021.
- ii. PHE dept. will organize an awareness program on hygiene and sanitization preferably in school and Anganwadi centers in cooperation with Social Welfare dept.
- iii. Agriculture dept. will conduct training on kitchen garden at digitized Anganwadi Centers of blocks and 10 such training programme should be organized covering entire Dev. Block.
- iv. A WhatsApp group on "Poshan Abhiyan" is to be opened. In this regard, the DIPRO was asked to carry out wide publicity of the activities under Poshan Mela.
- v. Two Yoga teachers are to be attached by DSO for one month training on yoga.
- vi. Due to lack of proper coordination between Health and Social Welfare dept, often reflects dissimilar nutritional data in various reports. Therefore the Social Welfare Dept. was instructed to take necessary steps to provide accurate data.

The Chairperson also instructed to submit proposal for one additional Nutritional Rehabilitation Center immediately.

- vii. The Chairperson directed Executive Engineer, PHE to complete the work of pipe water connection to various Schools and Anganwadi centers. Out of 746 such centers, 359 centers are yet to get pipe water connection.
- viii. DGM, APDCL was asked to take necessary steps to ensure separate billing for schools and Anganwadi centre located within the same campus.

2. Monitorable Target as per decision of D.C. Conference.

The Chairperson intimated the house that during recently concluded DCs Conference at Diphu on 22nd & 23rd August, some Monitorable Targets are given for Deputy Commissioner to be achieved from Sept.'2021 to March'2022. In this connection a power point presentation was presented on department wise action points of Monitorable Target and elaborately discussed the matter. The Chairperson directed all concerned department to act on Monitorable Target immediately and promptly. They are directed to submit action taken report on monthly basis before 6th of every month for onward submission to Govt.

3. Industry.

The representative of GM, DICC, Jorhat placed before the meeting that an area of the layout proposed for industrial complex is being held up by Bordoloi Gas agency which is yet to be vacated. Hence in this regard Industry Deptt. requested the District Administration to take necessary steps. The representative also informed that Industry department is going to organize "Banijya Saptah" from 24th Sept'2021 and relating to the Banijya Saptah a "Banijya Mela" will also be held. An "Exporter Conclave" also be held on 24th, 25th & 26th Sept'21 in connection with Banijya Saptah. The Chairperson instructed the Asstt. Dir, Sericulture, H&T, to extend full cooperation towards the programme and make it a success. The Chairperson also requested GM, DI&CC, Asstt. Dir, H&T, Sericulture to engage the unrest youth towards self employment programme and conduct various employment generation programme covering entire district monthly basis.

4. Irrigation

EE, Irrigation, Jorhat intimated that, 3 (three) of its earlier Division, e.g. Irrigation, Irrigation (Mechanical) & Irrigation (Investigation) merged in one Division at present. The excess manpower is now being under Central Monitoring. In this regard on a query from Chair, the EE informed that if any department requires Man Power (both Technical & Non Technical), they have to place requisition and accordingly Govt. will places man power.

5. Misc. Matter.

(a) DAO, Jorhat informed that "ATMA" Office at Koliapani Block is now used by "APART". The Chairperson instructed the DAO, DVO, DFDO, and Asstt. Dir, Sericulture to detail Technical Expert from their respective department thrice in a month at the ATMA Office, immediately with wide publicity and organize various self employment oriented programme.

- (b) DGM, APDCL informed that pole erection issues has already been sorted out at 33Kv line near Airport. He also informed that APDCL will introduce Smart Electric Meter shortly. EE WR requested the APDCL authority to disconnect the electric connection in the abandoned Govt. Quarter of Water Resource Deptt and also requested to shift the electrical pole from Kawoimari Embankment, Teok and department will bear shifting costs.
- (c) The Chairperson appealed entire HOD to conceive new ideas of alternative source of water in the next DDC meeting.
- (d) The Chairperson expressed displeasure over unauthorized absence of Departmental Heads from DDC Meeting and strictly directed to attend the meeting invariably now onwards, otherwise matter will be intimated to Govt.
- (e) The Chairperson instructed to write a letter to NHIDCL Authority, Jorhat to attend the DDC Meeting regularly as Special Invitee.

The meeting ended with a vote of thanks from the Chair.
