

**MINUTES OF DISTRICT DEVELOPMENT COMMITTEE MEETING OF JORHAT  
DISTRICT FOR THE MONTH OF FEBRUARY '2022 HELD ON 28/02/2022, IN THE  
CONFERENCE HALL OF DEPUTY COMMISSIONER'S OFFICE, JORHAT**

The members present are at Annexure I.

As the Deputy Commissioner, Jorhat was preoccupied with other urgent official works Sri Adhar Bhuyan, ACS, District Development Commissioner, Jorhat presided over the meeting. The Chairperson welcomed all the members present and initiated the discussion.

The progress of works of various development departments were elaborately discussed in the meeting and decision arrived as follows :

**1. Handloom & Textile**

The Asstt. Dir., H&T, Jrt , informed that no progress has been received regarding sanction of Mudra Loan , to the beneficiaries since last three months and till now only 2 beneficiaries got loans out of the total 127 application forwarded to the Banks The Chairperson instructed all concerned departments to submit Bank wise list of applicant to the LDM and accordingly LDM will communicate with the concerned Bank branches and submit a up to date status report on Mudra Loan along with all such bank linkage schemes. The LDM was also instructed take proper coordination with the Development department for early sanction of such loans with intimation to the Dist Admn. The Asstt. Director, H& T is directed to verify application properly before sending it to Banks.

**2. IRRIGATION**

The EE Irrigation Jorhat, Dergaon Teok Divn. intimated that, all agriculture field to be irrigated in phase manner under PMKSY, but target could not be fulfilled in Mariani LAC due to water level not found and boaring failed and those target has been shifted to Dergaon LAC . The Addl. Deputy Commr (Dev), instructed the EE to conduct a survey for identification of draught areas in coordination with Agriculture Department and write letter to Govt. through the Deputy Commissioner. The EE also intimated that 425 targets taken up under PMKSY and all are physically completed. The ADC (Dev) also requested to EE , Irrigation and DAO, Jorhat to take up awareness programme for multiple cropping amongst the farmers in proper coordination.

**3. SOIL CONSERVATION**

The D O, Soil Conservation, Jorhat informed that District Level Committee has been constituted and DPR preparation work is going on.

**4. LABOUR**

The Asstt. Commissioner, Labour, Jorhat informed that H&T and Health Department has already registered their workers under " e-SHRAM" . Detail discussion was held regarding registration under "e-SHRAM" of workers of Works department and to resolve the matter of registration. The ADC (Dev) directed the ALC, Jorhat to convene a meeting with PHE, Irrigation , Water Resources, PWD Deptt immediately. In this connection it was decided to hold the said meeting on 1<sup>st</sup> March '22 in the office Chamber of EE PHE, Jorhat and ADC (Dev) requested to all concerned department to attend the meeting positively.

#### 5. APDCL

The DGM, APDCL, Jorhat informed that only the civil construction part was completed for shifting works of Pulibor Sub Station, but remaining works yet to be done, as contractors is not willing to do the work at old schedule rate . In this connection the ADC (Dev) instructed the DGM to take up the matter with NHIDCL immediately and intimate. The DGM, APDCL intimated that under Green Energy Production Programme, 6 bighas of open land is required for installation of Solar panel to generate 400 KW of electricity and appealed the house to allot a plot of open land for the said purpose. In this regard representative of NCC Group HQ informed that they can provide roof top of NCC Training centre, Garmur if required.

#### 6. Water Resources.

The EE Water Resources Division, Jorhat informed that the Circle Officer Jorhat West have already carried out their alignment for fixation of new Embankment from Mohbondha PWD Rd. to NH 37, but said work could not be started , as the local people demanded an authentic land allocation certificate along with land holding details with the cadastral Trace Map. The ADC (Dev) requested the EE, WR, Jorhat to communicate with CO, Jorhat West Rev Circle for sorting out the matter and intimate.

#### 7. Health

The representative of Health Deptt informed that a new committee to be formed along with all line departments for execution of School Health Programme special inclusion of Veterinary and ICDS .

The ADC (Dev) appealed to all that for any grievances related to HIV + cases the Commr. UAD may be contacted who is the ombudsman authority for the same.

#### 8. Fishery

The DFDO, informed that under CMSGUY they required 11 bighas of land to set up a multi hatchery project, where 7 bighas needed for fishery purpose .The DFDO also intimated that two Fisheries of the district dried up due to depletion of water level at Jalukonibari and Cipahikhola and hence they have planned for taking up dredging activities to restore the water level, in this connection DFDO appealed to interested Deptt especially to PWD (Rds) and WR to collect the soil accumulated from the dredging activity. In this connection the DFDO is directed to submit the proper location of the Fisheries with route map to the concerned Engineers. The DFDO & DO, Soil Conservation was instructed to conduct a joint visit at Kalipani Veterinary Campus area and Misamari area under Jhanjimukh G.P. and report accordingly.

### 9. NCC

Participating as special invitee , the Group Commander , NCC, Jorhat informed the meeting , the NCC Hostel area in Garmur has been facing a lot of problems specially in case of drinking water , electricity , sewerage line and requested the house to look in to the matter for early solution . In this connection ADC (Dev) requested the EE, PHE to make a survey in that area and make provision to provide drinking water at least in the cooking house and prepare a feasibility report , she also instructed the EE PWD Electrical for repairing the electric line , in this context, EE , PWD (Elct.) informed that the allotted contractors still not received payment for earlier works . In this regard , ADC (Dev) requested the NCC authority to take up the matter with APDCL. The EE PWD (Bldg.) was also instructed to deploy contractors for repairing of sewerage line immediately to clear the water logging. The Group Commander also intimated the meeting that the Garbage yard at Borbheta junction point (Corner portion of Jail) becomes total hazard for the locality. In this connection the Chairperson requested the PHE to take up the matter with Zilla Parishad , Jorhat for survey of the area immediately and submit report.

### 10. PHE

The EE PHE informed the house that the PHE Office campus has been facing water logging problem due to overflow of water round the clock from the overhead water Reservoir of Urban Water supply and damaged the office building and Engineers residence. In this connection the Chairperson requested the EO, JMB, to conduct a survey of that area and take necessary action to prevent the overflow of water.

### 11. Sericulture

The Asstt. Director Sericulture intimated the house that they have 21 Hect. of vacant land ready for plantation and requested the line department to extended their cooperation in this regard . The Chairperson requested the Asstt. Director to communicate with Agriculture department for the said purpose and submit a report accordingly.

The meeting ended with a vote of thanks from the Chair.
