

MINUTES OF DISTRICT DEVELOPMENT COMMITTEE MEETING OF JORHAT DISTRICT FOR THE MONTH OF MARCH '2022 HELD ON 29/03/2022, IN THE CONFERENCE HALL OF DEPUTY COMMISSIONER'S OFFICE, JORHAT

The members present are at Annexure I.

The meeting was presided over by Sri Ashok Kr. Barman, IAS, Deputy Commissioner, Jorhat. The Deputy Commissioner, Jorhat welcomed all the members present and initiated the discussion.

The progress of works of various development departments were elaborately discussed in the meeting and decisions were arrived as follows:

1. Discussion on Mudra Loan

It was revealed during the discussion that no sanction has been accorded by concerned banks against departments sponsored beneficiary under Mudra Loan/ KCC / PMEGP. The matter was seriously viewed by the Committee. In reply to the query from Chair the LDM intimated that Bank wise details of loan application are yet to be received from the department concerned. In this regard the Chairperson directed all concerned departments to prepare a database on loan applications and to submit the same to LDM after proper verification at the earliest. The Chairperson instructed the LDM to facilitate opening of bank accounts on the basis of MCB card /Job Card to which LDM agreed.

2. Irrigation

The EE Irrigation Jorhat, was instructed by Chairperson that before executing the schemes they have to take due approval from Agriculture department verifying the cropping pattern of the irrigated area. The chairperson focused on providing better irrigation facilities to the King Chillli [Bhot Jolokiya] cultivators of Jorhat Region especially Nakachari, Boloma and Azarguri region.

3. Soil Conservation

The D O, Soil Conservation, Jorhat informed that District Level Committee has been constituted and DPR preparation work is going on. The Final DPR of PMKSY 2.1 Jorhat WDC under Titabor Range is under process and will be submitted within a day or two.

4. PHE

EE PHE, informed that 32 casual employees of PHE dept. were enrolled under E-Shram portal with due assistance from Labour Dept. In this connection Asstt. Labour Commissioner, Jorhat intimated that all issues related to "E-Shram" registration have been resolved.

5. APDCL

The Chairperson directed that unused land from Sericulture farm may be allocated to APDCL for execution of Green Solar Panels. The chairperson also requested other depts. to provide any unused departmental land for the same if available. The District Sports Officer, Jorhat requested the DGM, APDCL for installation of individual meter reading box at JDSA Commercial Complex. In reply to it the DGM, APDCL informed that once the pending bills of present Cluster meter of JDSA commercial complex is settled, then individual meter box would be installed.

The DGM , APDCL , Jorhat intimated that due to lack of proper demarcation at Hatisal Mising Gaon area, pole erection works couldn't be started. In this connection the chairperson instructed APDCL, PWD (NH) to communicate with the Circle Officer, Teok for a joint survey for quick redressal of the matter.

6. Water Resources.

The Chairperson directed EE, Water Resources to communicate with ADC, Revenue, for resolving the land issues relating to Mohbondha Embankment and report accordingly.

7. Fishery

DGM, APDCL requested to provide water bodies under Fishery Dept. for installation of Floating Solar Panels. The chairperson asked the DFDO to identify such water bodies and inform APDCL about the same.

8. Sericulture

The Chairperson instructed Asstt. Dir., Sericulture, Jorhat to motivate the Muga Rearer for clearing of unwanted jungle grass/plants of their farms. Participating in the discussion, the Asstt. Dir., Sericulture informed that 11 group of Muga Rearer are interested to conduct 10000 nos Muga dfls rearing in Jorhat district during jethua crop /2022 at subsidy rate of Rs 4/- per dfls and it will cost an amount of Rs.1.40 Lakh , but department has no available fund at present. In view of motivate and promote Muga cultivation in the district, the Chairperson is ready to provide Rs.1.00 Lakh from District Administration and remaining Rs. 40000 /- will be the beneficiaries' contribution.

9. NABARD

Participating in the discussion DDM, NABARD, Jorhat requested the concerned implementing department of RIDF Scheme to submit **drawal applications for already incurred expenses** to NABARD Regional Office. In this connection the Chairperson instructed the concerned Departments for timely submission of expenditure Bills for RIDF projects to NABARD for release of fund for smooth implementation of the projects. DDM, NABARD also requested to allot a room at Stadium Commercial Complex , Jorhat for a local educated unemployed youth who got ACABC Project , which is a scheme of Department of Agriculture and Farmers Welfare , GOI with NABARD . In this connection the Chairperson instructed the DSO to look into the matter for allotment of room.

Miscellaneous Discussion

- a. The Chairperson informed all that District Administration is going to organize 3 (three) day "Employment Generation Conclave" to promote entrepreneurship activities in the district from 7th to 9th April '2022 at Court Field. He requested all heads of development department for their cooperation and active participation to make it a grand success. In this connection the Chairperson requested all esteemed members to communicate with Ms. D. Boruah, ACS, SDO (Sadar) , Jorhat , Liaison Officer of the programme.
- b. The Chairperson appealed all heads of department to submit their departmental success stories (if any) in order to create awareness and motivate others in their line of performance. The Chairperson also requested all heads of departments to spare time for visiting such successful schemes, which will create proper coordination amongst all the Government Departments.
- c. The Chairperson requested EE PWD (NH) , Jorhat to keep in close touch with NHIDCL authority for widening of the approach of Guwahati Gate road in view of the National Security interest as opined by Indian Air force.
- d. The meeting decided to visit the Greater Jorhat Water Supply Project at Potia Fokala on 2nd April'22 by all the heads of the Dev. department as a part of Chairperson's *success story imitative*.
- e. The Chairperson instructed EE, PWD (Roads) to complete the Assam Mala schemes immediately.
- f. The Chairperson appreciated the efforts of APDCL and Transport Department on their respective revenue collection performances.
- g. The Chairperson instructed Supdt. of Excise, Jorhat to expedite raids of illicit local liquor (Chulai) in the district frequently.

The meeting ended with a vote of thanks from the Chair.
