NOTICE

Persuant to para 3 (iv) of the Govt. Notification No. RLA.177/2021/3 dated 07/03/2022, the District Level Land Purchase committee (DLLPC), Jorhat, after being satisfied that for the public purpose, the land, the brief description of which is given in the Schedule below, is required for the acquisition of land for improvement and up gradation of Lachit Maidam Park at Village Narahiloidari under Hulungapara Mouza of Teok Revenue Circle in the district of JORHAT in the state of ASSAM, hereby declares its intention to acquire such land by direct purchase.

Any person interested in the said land may, within one (1) month from the date of publication of this notification, object to the use of such land for the aforesaid purpose under para 4 (vi) of the said notification. Every such objection shall be made to the Chairman, DLLPC, Jorhat namely, DEPUTY COMMISSIONER/ DISTRICT COLLECTOR in writing and shall set out the grounds thereof and the Chairman, DLLPC shall give the objector an opportunity of being heard, either in person or by a legal practitioner, and may, after hearing all such objections and after making such further enquiry, if any, as the Chairman, DLLPC thinks necessary, by order, either allow or disallow the objections.

This notification is published for acquisition of land through direct purchase through negotiated settlement for improvement and upgradation of Lachit Maidam Park.




